Privacy Policy

Because FC Pride Soccer Club values the privacy of our families and visitors to our websites, we do not share any of your personal information, submitted on this web site, with anyone other than internal company personnel.

FC Pride Soccer Club provides “links” to a wide variety of other web sites on the Internet. In addition, many of our links maintain their own privacy policies that may be viewed on their web sites. We are not responsible for their privacy policies or how those websites manage information about their users. This Privacy Policy applies solely to the information collected on www.fcpride.org or any of our sister websites and the conduct of FC Pride Soccer Club.

Please note that by visiting and using www.fcpride.org or any of our sister websites, you are accepting the practices described in this Privacy Policy. If we decide to change our Privacy Policy, we will post those changes www.fcpride.org or any of our sister websites so that you are always aware of what information we gather and how we use it.

The Information We Gather

FC Pride Soccer Club does not collect any personal information from a visitor to our web site unless that visitor explicitly and intentionally provides it. If you are simply browsing our web site, we do not gather any personal information about you. There are ways in which you may explicitly and intentionally provide us with and consent to our collection of certain personal information:

1. **E-mail request for information** – We use links throughout our web site to provide you with the opportunity to contact us via e-mail to ask questions, request information and materials, or provide comments or suggests. You may also be offered the opportunity to have one of our representatives contact you personally to provide additional information about our products or services. To do so, we may requests additional personal information from you, such as your name and telephone number, to help us satisfy your request.

2. Electronic Registration/ Online Payment– If you choose to register online for one of our programs or pay for services; we will request certain information from you. Depending on the type of product or service that you request, you may be asked to provide different personal information. For certain products and services, we may require your name, address, telephone number, e-mail address, credit card number, bank account information, IP address, and/or identity number. Other products and services may require additional or supplemental information from you in order to purchase.

In addition, information we automatically collect via industry standard web log files includes the URL from which you visited, the page you are visiting, your computer browser information and your IP address. We may also track the effectiveness of various features of our web site through the use of data collection devices known as “cookies.” Cookies contain specific pieces of information on your computer hard drive, and can be set to store information during a visit or for a longer period of time. Our cookies are not tied to personally identifiable information.

How We Use the Information We Gather

First, FC Pride Soccer Club responds to any e-mail questions, requests for product or service information, and other inquiries that we receive. We may also retain this correspondence to improve our products, services, and web site, and for other disclosed purposes. Frequently we retain contact information so that we can send families updates or other important information about our programs and events. If we are required by law to disclose certain information to local, state, federal, national or international government or law enforcement authorities, we will do so. We will also disclose information to third parties as necessary in order to comply with applicable laws and regulations. In addition, FC Pride Soccer Club may share information in order to investigate, prevent, or take action regarding illegal activities or suspected fraud, or enforce or apply FC Pride Soccer Club’ agreements.

Information Security

The systems used by FC Pride Soccer Club are verified as “secure and reliable” by Thawte Consulting. Information through Hammerhead Communications, our web hosting company, everything is secured both during transmission and online storage. If a particular system developed for FC Pride Soccer Club involves integrated payment processing (Credit card, Pay Pal, e-Checks, etc.), the account information is not stored in the database we developed. Rather, the account information is stored by the credit card processor, Pay Pal or banking institution. Please contact FC Pride Soccer Club with any and all questions related to payment processing or payment refunds.

Children’s Privacy

Consistent with the Federal Children’s Online Privacy Protection Act of 1998 (COPPA), we will never knowingly request personally identifiable information from anyone under the age of 13 without requesting parental consent.
